## Penwood Real Estate Investment Management Announces the Final Close of its Sixth Value-Add Industrial Fund

West Hartford, CT – February 12, 2021 – Penwood Real Estate Investment Management, LLC ("Penwood") has closed its sixth value-added investment vehicle, Penwood Select Industrial Fund VI, L.P. (the "Fund" or "Fund VI"). Fund VI is a closed-end, commingled partnership fund that will acquire and create industrial real estate properties in the major global gateway markets of Southern California and the Northeastern United States. Investments will be pursued through acquisition, management, rehabilitation, redevelopment and development of industrial properties in order to acquire or manufacture properties at or below replacement cost. Penwood will utilize its value-added risk management processes and experience to enhance the return on Fund investments. Within the dominant U.S. seaport industrial markets, Fund VI will aggregate an industrial property portfolio with an expected cost advantage compared with a market-bid core acquisition strategy. The transactions will be sourced directly and through the preferred relationships Penwood has established with its select group of operating partners.

Penwood's analysis of the current economic and real estate investment environment indicates that within the industrial sector, and specifically in the densely populated markets of Southern California and New York/New Jersey, the opportunity for acquiring assets is attractive. The supply-restrained nature of the real estate markets of Southern California and the Northeastern United States has provided a historically attractive investment climate. Further supporting the appeal of investment in the target industrial markets is the positive outlook for improving user demand and rental growth. The desirable attributes of the target markets are expected to provide a favorable environment for the Fund to execute its investment strategy.
